## **HB2041 - Mental health; voluntary evaluations; payment**

### **Sponsor**

Rep. Selina Bliss (R)

### **Summary**

During the process for court-ordered mental health evaluations, if a person who requested a voluntary mental health evaluation does not appear or does not complete the appointments scheduled, the provider who was to conduct the evaluation is required to immediately notify the evaluation agency provided for by the county, and the evaluation agency is required to provide pre-petition screening of the application for court-ordered mental health evaluation. When a person is given a voluntary mental health evaluation, the person is required to pay all or a portion of the established charges as the person can afford. If the person is indigent, charges cannot be made against the person. AS PASSED SENATE

**HB2043 - Physician assistants; supervision; collaboration**

## Summary

Licensed physician assistants (PAs) who have at least 8,000 hours of clinical practice certified by the Arizona Regulatory Board of Physician Assistants are no longer required to be supervised by a licensed physician, and instead are required to collaborate with or refer to the appropriate health care professional as determined by the policies of the practice setting at which the PA is employed. PAs are authorized to provide any legal medical service for which the physician assistant has been prepared by education, training and experience and that the physician assistant is competent to perform. PAs who have less than 8,000 hours of clinical practice certified by the Board are required to work in accordance with a supervision agreement that describes the PA's scope of practice. A PA who does not practice under a supervision agreement is legally responsible for the health care services performed by the PA. A PA is allowed to bill and receive direct payment for the professional services provided by the PA. Effective January 1, 2024. AS SIGNED BY GOVERNOR

## **HB2194 - Drug overdose fatality review teams**

### **Sponsor**

Rep. Quang H. Nguyen (R)

### **Summary**

Establishes a 20-member Drug Overdose Fatality Review Team in the Department of Health Services and requires the Review Team to develop a drug overdose fatalities data collection system, develop protocols for drug overdose investigations, and determine statutory and regulatory changes needed to decrease the incidence of preventable drug overdose fatalities. Establishes processes for the Review Team to access information and regulates the confidentiality of information and records acquired by the Review Team. Review Team meetings are closed to the public and are not subject to open meeting law if the Review Team is reviewing information on a person who overdosed on drugs. Violations of the confidentiality requirements are a class 2 (mid-level) misdemeanor. Self-repeals January 1, 2029. Emergency clause. AS SIGNED BY GOVERNOR

## **HB2336 - Tuition; family; posttraumatic stress; suicide**

### **Sponsor**

Rep. Amish Shah (D)

## Summary

The Arizona Board of Regents (ABOR) or a community college district is required to provide a tuition waiver scholarship to the child or spouse of an Arizona resident who was a veteran of the U.S. Armed Forces or served as a peace officer or firefighter, who suffered a posttraumatic stress injury in the line of duty, and who died by suicide. Tuition waiver scholarships are limited to children who are 30 years of age or younger and spouses who have not remarried. A person who meets these requirements on the effective date of this legislation is eligible to receive a tuition waiver scholarship regardless of the date on which the eligible person's parent or spouse suffered the posttraumatic stress injury or died by suicide. If sufficient monies are available, ABOR is required to distribute monies that were appropriated to the Spouses of Military Veterans Tuition Scholarship Fund to each university under ABOR jurisdiction for the costs associated with the tuition waiver scholarships established by this legislation. ## **HB2346 - Outpatient treatment centers; exemption**

## **HB2451 - Prescription digital therapeutics; pilot program**

## **HB2470 - AHCCCS; rapid genome sequencing**

## **HB2530 - Substance exposure; pregnant women; neglect**

### **Sponsor**

Rep. Rachel Jones (R)

### **Summary**

On a finding of a pregnant woman using alcohol or a dangerous drug or narcotic drug, through clinical indicators in the prenatal period, a licensed or certified health care professional is required, with the woman's consent, to refer the woman to substance use services and support to facilitate maternal and infant safety, in addition to reporting to the Department of Child Safety (DCS) as required by statute. If DCS receives a communication involving substance use by a pregnant woman, DCS is required to provide the caller with the contact information for the Arizona Health Care Cost Containment System (AHCCCS) and transfer the call, if possible. AHCCCS is required to refer the woman to a provider for substance use treatment. The receipt of a communication involving substance use by a pregnant woman is prohibited from resulting in a DCS investigation of abuse or neglect. In determining if a child is neglected, proof that the mother participated in substance use treatment certified by a health care professional may be considered a mitigating factor. AS PASSED SENATE

guidance that is contrary to the requirements of this legislation, following any other timelines or deadlines, or limiting the initiation or completion of redeterminations or removals, unless required to do so under federal law. Self-repeals January 1, 2025. Also requires the AHCCCS Administration to submit a monthly report to the Governor and the Legislature from May 15, 2023 through May 15, 2024 containing specified information on AHCCCS renewals. Makes a supplemental appropriation of \$29.24 million from the Children's Health Insurance Program Fund and \$1.65 billion from expenditure authority in FY2022-23 to the AHCCCS Administration for adjustments in formula requirements. ## SB1220 - Alzheimer's disease state plan; appropriation

### Summary

The Arizona Department of Health Services (ADHS) is designated as the lead agency in Arizona to address Alzheimer's Disease and related forms of dementias. ADHS is required to develop an Alzheimer's Disease State Plan to assess the impact of Alzheimer's Disease and dementia on Arizona, assess the existing state services that address the needs of persons who have Alzheimer's Disease or dementia and their family caregivers, and provide a strategic plan for state action to increase access to care, support, and treatment, improve quality of care, advance risk reduction and early detection, and ensure a coordinated statewide response. The ADHS Director is required to establish a Dementia Services Program within ADHS that meets a list of specified requirements, including facilitating the coordination and implementation of the Plan. By July 1, 2024 and every third year after, ADHS is required to review the Plan and submit an updated Plan to the Governor and the Legislature. Appropriates \$300,000 from the general fund in FY2023-24 to ADHS for the Program and the implementation of the Plan.

## **SB1249 - Medical licensing; study committee (International medical graduates; licensure.)**

### **Sponsor**

### **Summary**

Beginning January 1, 2024, the Arizona Medical Board (AMB) is required to grant a provisional license to practice medicine in Arizona to an international medical graduate who is a U.S. citizen that has been granted a medical doctorate or a substantially similar degree by an international medical program of goods standing, who has an offer for employment as a physician at any health care provider that operates in Arizona, who meets the requirements for licensure, and who meets other specified requirements. A provisional license under these circumstances is automatically converted into a full license after three years unless AMB disciplines the licensee in that period. Also establishes a 19-member Study Committee on Physician Shortages to research and make recommendations for addressing the physician shortage in Arizona, with an emphasis on encouraging more physicians to practice in rural areas and low-income communities. The Committee is required to submit a report of its findings and recommendations to the Governor and the Legislature by December 1, 2024, and self-repeals January 1, 2025. AS PASSED SENATE

## **SB1250 - Employers; vaccines; religious exemption**

### **Sponsor**

Sen. Janae Shamp (R)

### **Summary**

Employers would have been required to allow employees to claim a religious exemption from taking the COVID-19 vaccination, influenza A or B vaccination or flu vaccination, or any vaccination approved by the U.S. Food and Drug Administration for emergency use. Employers would have been prohibited from inquiring into the veracity of an employee's religious beliefs, and from discriminating against an employee regarding employment, wages, or benefits based on the employee's vaccination status. Employees would have been authorized to file a complaint with the Attorney General (AG) if the employer did not offer the employee a religious exemption form or improperly applied or denied the employee's religious exemption and the employee's employment was terminated. The AG would have been required to investigate all complaints. If the AG found a complaint valid, the AG would have been required to notify the employer and allow the employer the opportunity to correct the noncompliance within 10 days. The AG would have been required to assess a civil penalty of \$5,000 on an employer that did not correct the noncompliance. AS VETOED BY GOVERNOR. In her veto message, the Governor called this bill unnecessary, as legal protections for an employee's religious beliefs already exist in federal employment law.

## **SB1334 - Advanced practice nurses; compact**

### **Sponsor**

Sen. Janae Shamp (R)

### **Summary**

Adds a new article to Title 32 (Professions and Occupations) establishing an advanced practice registered nurse (APRN) compact, which allows licensed nurse to apply for an APRN multistate license. All party states to the compact are required to participate in a coordinate licensure information system to assist in the coordinated administration of APRN licensure and enforcement efforts. The party states establish a joint public agency known as the Interstate Commission of APRN Compact Administrators. Powers and duties of the Commission are specified, including a rulemaking process. Establishes procedures for oversight, dispute resolution, and enforcement. The compact becomes effective when it is enacted into law in seven party states. Provides for withdrawal from the compact, amendments to the compact, and construction of the compact. The compact does not supersede state law related to APRN scope of practice, and the Commission does not have the authority to alter the APRN scope of practice. AS PASSED SENATE

## **SB1466 - Medical marijuana; adult-use marijuana**

### **Sponsor**

Sen. Thomas "T.J." Shope (R)

### **Summary**

By December 31, 2023, any marijuana or marijuana product packaging labeled for sale is required to include a consumer scannable tetrahydrocannabinol quick response code or similar technology linking to a webpage that displays a list of specified information for the specific marijuana product, including required warnings as determined by the Arizona Department of Health Services. By December 31, 2023, nonprofit medical marijuana dispensaries are required to procure, develop, acquire and maintain a system to track marijuana and marijuana products at all points of cultivation, manufacture and sale. Requirements for the system are listed. Nonprofit medical marijuana dispensaries are required to sell marijuana and marijuana products in clearly and conspicuously labeled containers with accurate warnings regarding their use, and in child-resistant packaging on exit from the dispensary. Nonprofit medical marijuana dispensaries are prohibited from packaging or labeling marijuana or marijuana products in a false or misleading manner, and from selling or advertising marijuana or marijuana products to children or with names that resemble or imitate food or drink brands marketed to children. Repeals the Medical Marijuana Testing Advisory Council. Contains a legislative intent section. Due to voter protection, this legislation requires the affirmative vote of at least 3/4 of the members of each house of the Legislature for passage. AS PASSED SENATE

## **SB1600 - Infants; born alive; requirements**

### **Sponsor**

Sen. Janae Shamp (R)

### **Summary**

Any infant who was born alive, including one born during the course of an abortion, would have been required to be treated as a legal person under the laws of Arizona and would have had the same rights to medically appropriate and reasonable care and treatment. Birth and death certificates would have been required to be issued for the infant, as appropriate. Any health professional who was present at the time an infant was born alive would have been required to take all medically appropriate and reasonable actions to preserve the life and health of the infant who was born alive. Any health professional, hospital, abortion clinic, or employee or volunteer of a hospital or abortion clinic that had knowledge of a failure to comply with these requirements would have been required to immediately report the failure to law enforcement. Would not have prevented an infant's parent or guardian from refusing to give consent to medical treatment or surgical care that was not medically necessary or reasonable. AS VETOED BY GOVERNOR. In her veto message, the Governor stated that this bill interferes with the relationship between a patient and doctor and that it is not the state's role to make such difficult medical decisions for patients.

## **SB1602 - Dental anesthesia; requirements**

### **Sponsor**

Sen. Janae Shamp (R)

## Summary

The Arizona Medical Board, the Arizona Board of Osteopathic Examiners, and the Arizona State Board of Nursing are authorized to register licensees who meet specified requirements to administer anesthesia in dental offices and dental clinics. Persons who are registered under these provisions are defined as “qualified anesthesia providers” and requirements for these providers are established. A State Board of Dental Examiners licensee who has obtained a permit for applying general anesthesia is authorized to perform dental procedures on a patient who receives an anesthetic administered by a qualified anesthesia provider who is exclusively responsible for the preoperative, intraoperative and postoperative anesthetic management of the patient. A dental office or dental clinic at which general anesthesia or deep sedation is administered is required to contain properly operating equipment and supplies and to have proper emergency response protocols in place. If a death or an incident requiring emergency medical response occurs in a dental office or dental clinic during the administration of or recovery from general anesthesia or sedation by a licensed physician or certified registered nurse anesthetist, the treating dentist is required to report the incident to the State Board of Dental Examiners and the physician or nurse anesthetist is required to report the incident to the applicable regulatory board within three business days after the occurrence. By September 1, 2023, the State Board of Dental Examiners Anesthesia and Sedation Committee is required to submit final recommendations to improve the general anesthesia and sedation permit requirements. Requirements for the final recommendations are specified. The Board is required to approve, modify, or reject the recommendations within 60 days after receipt. AS PASSED SENATE
